Familiarisation Programme for Independent Directors

(In terms of Regulation 25(7) of the SEBI LODR)

Preamble

In terms of the provisions of Regulation 25(7) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Regulations"), every listed entity is required to familiarize the Independent Directors, through various programmes, about the company, including the nature of industry in which the company operates, business model of the company, roles, rights, responsibilities of Independent Directors etc.

- Presentations on internal control over financial reporting, Companies (Amendment) Act, 2017, Revised Secretarial Standards on Board and General Meetings, SEBI (Listing Obligations and Disclosure Requirements) (Amendment) Regulations, 2018 and other regulatory updates.

The Executive Directors, Senior Management and Business Heads conduct programmes / presentations periodically to familiarize the Independent Directors with the strategy, operations and functions of the Company.
